### Who are we?

Stockholm Community Daycare is a registered charity (#72989 8536 RR0001) formed in 2020 by a passionate group of community members dedicated to bringing quality, affordable early childhood education to Stockholm, SK. We see the continued success of our daycare as a powerful way to add value to our community and ensure its ongoing stability and growth. With support from our generous donors, outstanding community, and the *Canada-Saskatchewan Canada-Wide Early Learning and Child Care Agreement*, we became operational in April of 2022!

### Is there really a need for daycare in Stockholm?

Yes! We are currently at capacity with 40+ toddler and pre-school-aged children from Stockholm, surrounding communities, and farm families. We maintain a growing waitlist of children in immediate need of early childhood education services! Sustainable daycare options are vital for economic growth; it allows parents to return to work and companies to recruit and maintain valuable employees. Our complete Needs Assessment is posted online.

### What are your plans for 2023?

We are grateful for the continued support of our community and Ministry grant funding! However, continued support is still required to enhance our programming opportunities, lower out-of-pocket expenses for families, and maintain optimal conditions that attract and retain passionate employees. We have several facility upgrades expected in 2023, including building a rear porch access to improve accessibility and fire safety, window upgrades to improve temperature control and air flow, and a new furnace for safety assurance over our cold winter months. We also hope to expand our services to school-aged children this summer with before-and-after school care options available in the fall. Finally, we recognize the local need for extended daycare hours and are exploring opportunities to best accommodate families within the mining, agriculture, and healthcare sectors.

### How will donors be recognized?

All donors will receive recognition on our Facebook page, website, and print promotions. Bronze and higher donations (\$50+) will receive enhanced digital recognition. Silver and higher (\$100+) donations will have a logo or ad on our website. Gold (\$500+), Diamond (\$1,000+), and Diamond+ (\$20,000+) donors will receive recognition signage at the daycare facility and further promotions.
